



Application Policies for New Students

INITIAL REGISTRATION PROCEDURES:

1. Submit completed Online Application and pay application fee.
2. Submit the following to the school:
 - a. Birth Certificate
 - b. Most recent report card
 - c. Most recent standardized testing
 - d. IEP if applicable
3. Submit "Teacher Recommendation" to the student's present school
4. Complete entrance testing requirement

***YOU WILL BE NOTIFIED OF ACCEPTANCE AND FINAL REGISTRATION PROCEDURES**

IMPORTANT:

1. ADMISSION DECISIONS WILL BE BASED ON THE APPLICANT'S MEETING LCS ADMISSION STANDARDS. ACCEPTANCE WILL NOT NECESSARILY BE BASED ON THE REGISTRATION DATE.
2. GRADE PLACEMENT OF NEW STUDENTS RESTS WITH THE ADMINISTRATION AND THE ADMISSIONS COMMITTEE.
3. A PROBATIONARY PERIOD OF NINE (9) SCHOOL WEEKS FOR ALL NEW STUDENTS WILL BE REQUIRED FOR FINAL ACCEPTANCE. WRITTEN NOTIFICATION TO PARENTS OF ANY CHANGE IN ACCEPTANCE WILL IMMEDIATELY FOLLOW THE NINE (9) WEEK PROBATIONARY PERIOD.
4. APPLICATIONS CANNOT BE PROCESSED UNTIL THE ONLINE APPLICATION IS COMPLETE WITH THE FEE SUBMITTED. BIRTH CERTIFICATE, MOST RECENT REPORT CARD AND MOST RECENT STANDARDIZED TESTING ARE RECEIVED BY THE SCHOOL.
5. MEDICAL RECORDS 3040 & 680 MUST BE UP TO DATE AND ON FILE IN THE SCHOOL OFFICE BEFORE THE STUDENT MAY ATTEND SCHOOL.

AGE REQUIREMENTS:

1. Kindergarten: 5 years old by September 1 of entering year
2. Grade 1: 6 years old by September 1 of entering year
